Examination Rules and Regulations:

- The eligibility criteria for students to write the certificate course exam is as follows:

S. No.	Levels	Minimum Age Limit
1.	Akaram	5 Years
2.	Ikaram	7 Years
3.	Ukaram	10 Years
4.	Lakaram	13 Years
5.	Cikaram	15 years

- The exam fee and completed application form must be sent to TVA at least 10 days before the exam date. The application form and fee

transaction details can be sent either by post or email (tva@tn.gov.in). Ensure that the application form is complete and the fee is paid in full before sending it to TVA.

- If the registration fee and exam fee are not received by TVA at least 10 days before exam, then the student can appear for the exam only after payment of the late fee (in addition to the registration fee and exam fee) as specified in the table.
- Students are not allowed to bring electronic devices, books, or any other materials into the exam hall.
- Students should be present in the exam hall at least half an hour (30 minutes) before the exam starts.
- For Examination registration an amount of Rs30/- per student will be given to the Examination Coordinator. (Out of Rs.550/-, Rs.30/- goes to exam coordinator, deduct Rs.30 and the balance amount Rs.520/- per student will deposit to TVA account)
- Registration and Examination fees will be exempted fully for Student who are all enrolled under Right to Education Act 2009. Student list for the Right to Education act should be submitted separately along with their details.
